The Board of Elections of Screven County, Georgia, Mrs. Veronica Bing, Mrs. Rosalind Evans, Mrs. Mary Felton and Mr. Burton Kemp met in regular session at 4:00 P.M. on April 4, 2024 at the Screven County Courthouse.

Call To Order, Invocation, and Pledge of Allegiance

Mr. Burton Kemp called the meeting to order. Mrs. Rosalind Evans gave the invocation and Mr. Burton Kemp led the Pledge of Allegiance.

Agenda Approval

Mrs. Rosalind Evans made a motion amendment to correct the attendees list of the March meeting from Rachel to Ramah. Mrs. Mary Felton seconded the amendment. Mrs. Veronica Bing made the motion to approve the amended minutes. Mrs. Mary Felton seconded the motion and it carried by unanimous vote.

Public Comment

There was no public comment.

New Business

- 1) **By-Laws**-After discussion a motion was made to amend the By-Laws by Mrs. Rosalind Evans. Mrs. Veronica Bing seconded the motion and it was approved by unanimous consent. See Bylaws section for most current Bylaws.
- 2) **Voter Drives**- Mrs. Veronica Bing discussed ideas for upcoming voter drives. The motion was made to table the discussion until next month when a specific plan would be proposed. Mrs. Veronica Bing made the motion, Mrs. Mary Felton seconded the motion and it passed unanimously.
- 3) **Sunday Voting** –A motion was made to allow Sunday voting for one Sunday during Advanced in person Voting. Mrs. Veronica Bing made the motion, Mrs. Rosalind Evans seconded, and it was approved unanimously. Mrs. Veronica Bing made a motion that Sunday voting would be held on the Sunday after the 2nd Saturday of advanced voting from 10:00 AM – 4:00 PM, but Sunday Voting for the General Primary in May would be held on the Sunday after the first Saturday, to avoid conflict with Mother’s Day. Mrs. Rosalind Felton seconded the motion. The motion was unanimously approved.

- 4) **Consider keeping Tech support on Election night-** The Board discussed keeping tech support for the General Primary in May. Mrs. Mary Felton made the motion, Mrs. Veronica Bing seconded the motion and it passed unanimously.
- 5) **Consider using radio advertising for election information-** The board discussed using radio advertising to publicize election dates and information. They decided not to move forward with paid advertising and to continue using other methods.
