CALL TO ORDER, INVOCATION AND PLEDGE OF ALLEGIANCE

MINUTES

Commissioner Triplett made a motion to approve the minutes of the January 14, 2020. Commissioner McBride seconded the motion and it carried by unanimous vote.

APPEARANCE(S)

(1) **Russell Waters** spoke to the Board on behalf of the Airport Authority regarding the waste disposal site. Mr. Waters stated the Authority feels the landfill is unsafe, they are against it and they want to be informed of all meetings in the future.

NEW BUSINESS

(1) **Discussion** Commissioner Triplett continued the discussion of inert debris and stated that our Consultant Doug Eaves recommends that we do not accept the debris at the landfill.

EXECUTIVE SESSION
